Dear Mr. Neandross,

I appreciate your February 2, 2016 response regarding my January 12, 2016 letter about Coalition for Clean Air (CCA) President Joseph K. Lyou and my January 26, 2016 letter about CCA Board Member and UC Riverside Professor Ronald K. Loveridge. For your information, I spoke at the June 4, 2008 Senate Rules Committee confirmation hearing of Lyou and I spoke in person to Loveridge on December 3, 2008. Since 2008, Lyou and Loveridge have NEVER responded to me regarding any of the numerous public comments that I have submitted to SCAQMD and CARB. Thus, your response indicates a high degree of professionalism. However, I am disappointed that the CCA Board Executive Committee will take no action regarding Lyou.

In order to understand why I am so concerned about SCAQMD and Lyou, please read about my Brother Randy Thomas of Watts (<http://www.scientificintegrityinstitute.org/Thomas120712.pdf>). Notice in the photo that Randy has his arm around me because I care that his 40-year Watts trucking company was destroyed by the SCAQMD "Clean Truck Program." Please listen to his profound 9-minute comments to Lyou and Loveridge, as well as to Burke and Wallerstein, at the December 7, 2012 AQMP Hearing (<http://www.scientificintegrityinstitute.org/Thomas.MP3>). Following this hearing, Lyou, Loveridge, Burke, and Wallerstein did NOTHING to help Randy.

Thus, I am going to make a strong case in various appropriate scientific, business, and political forums that Lyou and the CCA Board simply do not care about people like my Brother Randy. If you personally have any concern about Randy, I will ask him to contact you.
